# MEMBERSHIP BILLING FAQS



#### WHEN DO I NEED TO PAY YOU?

The Austin Board of REALTORS® has three (3) billing cycles annually in March, September, and December. Be sure to add these dates to your calendar to avoid any fees or interruptions to your services.

#### **MARCH**

#### Spring MLS + KEY Billing

Invoices Posted: March 1 Payment Due: March 31 Service Cut-Offs: April 1

#### **SEPTEMBER**

#### Fall MLS + KEY Billing

Invoices Posted: September 1
Payment Due: September 30
Service Cut-Offs: October 1

#### **DECEMBER**

#### **Association Membership Billing**

Invoices Posted: December 1 Payment Due: December 31 Service Cut-Offs: January 1

#### FREQUENTLY ASKED QUESTIONS

#### How will I know when my invoices are available for payment?

Invoices will be posted on your Member Portal at Portal. ABoR. com and you will receive an automated email letting you know your invoice has been posted. You will also receive reminder email communications 14 days, 7 days, and 24 hours in advance of your payment being due.

#### What happens if I don't pay my invoice by the due date?

Failure to pay your billing invoice by the due date will result in an immediate suspension of services and a reinstatement fee will be added to your account. If your services are suspended for nonpayment, you can log into your Member Portal at Portal.ABoR.com to pay your account balance and reinstate services. ABoR and MLS services are reactivated within minutes; Supra KEY services will take up to the next business day to fully reactivate.

#### How much are reinstatement fees?

Reinstatement fees are \$16.24 for Unlock MLS subscriptions, \$16.24 for Supra KEY subscriptions, and \$27.06 for Association membership. All of these amounts have sales tax included.

#### Do I have to pay an application fee if I'm a returning ABoR member or Unlock MLS subscriber?

Association and Unlock MLS application fees will be assessed to any returning accounts who have had one full billing cycle lapse without membership or service. This is in addition to any outstanding invoices or reinstatement fees that are due from previous service. A full billing cycle equates to 12 months for Association membership and six months for an Unlock MLS subscription.

#### Am I eligible for waived or prorated fees if my services have been suspended?

Reinstating accounts are not eligible for any proration or waiver of membership and/or subscription fees.

#### Can I get a refund on my ABoR membership, Unlock MLS subscription, or Supra KEY subscription fees?

All ABoR, Texas REALTORS®, and National Association of REALTORS® membership fees; Unlock MLS subscription fees; and Supra KEY subscription fees are nonrefundable.

#### **PAYMENT METHODS**

As of January 2021, all credit card payments must be made online and split payments are not accepted. Checks under \$2,500 are not accepted in house and must be processed online through our Member Portal e-check feature.
